RECOMMENDING TO THE HEAD OF THE PROCURING ENTITY THE AWARD OF CONTRACT TO DEPED REGION IV-A CALABARZON MULTIPURPOSE COOPERATIVE FOR THE PROCUREMENT OF CATERING SERVICES FOR THE CONDUCT OF THE 2024 KAPIHAN SA BAGONG PILIPINAS

WHEREAS, DepEd Regional Office IV-A CALABARZON has undertaken procurement of CATERING SERVICES for the CONDUCT OF THE 2024 KAPIHAN SA BAGONG PILIPINAS on OCTOBER 14-15, 2024;

WHEREAS, the Approved Budget for the Contract (ABC) is TWENTY-NINE THOUSAND NINE HUNDRED PESOS (Php29,900.00);

**WHEREAS,** Section 53.9 of the 2016 Revised Implementing Rules and Regulations (R-IRR) of Republic Act 9184, otherwise known as the "Government Procurement Reform Act of 2003", allows an agency to resort to Small Value Procurement as alternative method of procurement where the amount involved does not exceed the threshold amount of One Million Pesos (Php1,000,000.00) as prescribed in Annex "H" thereof;

**WHEREAS**, the Request for Quotation (RFQ) was posted in the office website and conspicuous bulletin board in the premises of this Office starting on October 4, 2024 to October 9, 2024 at 9:00 a.m.;

**WHEREAS**, RFQs were sent to at least three (3) prospective suppliers as follows: (1) God's Treasure Enterprises; (2) DepEd Region IV-A CALABARZON Multipurpose Cooperative; and (3) Focal Managing Loop Inc.;

**WHEREAS**, two (2) suppliers submitted their respective proposals before the deadline for the submission of quotations, offering the following financial quotations, as read:
