**WHEREAS**, DepEd Regional Office IV-A CALABARZON has undertaken procurement of **CATERING SERVICES** for the **OFFICE OF THE REGIONAL DIRECTOR (ORD) QUARTERLY DIVISION PROCESS REVIEW** on **OCTOBER 16-17, 2024**;

**WHEREAS**, the Approved Budget for the Contract (ABC) is **EIGHTEEN THOUSAND PESOS (Php18,000.00)**;

**WHEREAS**, Section 53.9 of the 2016 Revised Implementing Rules and Regulations (R-IRR) of Republic Act 9184, otherwise known as the "Government Procurement Reform Act of 2003", allows an agency to resort to Small Value Procurement as alternative method of procurement where the amount involved does not exceed the threshold amount of One Million Pesos (Php1,000,000.00) as prescribed in Annex "H" thereof;

**WHEREAS**, the Request for Quotation (RFQ) was posted in the office website and conspicuous bulletin board in the premises of this Office starting on October 7, 2024 to October 10, 2024 at 9:00 a.m.;

**WHEREAS**, RFQs were sent to at least three (3) prospective suppliers as follows: (1) Focal Managing Loop Inc.; (2) God's Treasure Enterprises; and (3) DepEd Region IV-A CALABARZON Multipurpose Cooperative;

**WHEREAS**, two (2) suppliers submitted their respective proposals before the deadline for the submission of quotations, offering the following financial quotations, as read:
