RECOMMENDING TO THE HEAD OF THE PROCURING ENTITY THE AWARD OF CONTRACT TO SUNNY GLADES PROPERTIES CORPORATION (TAGAYTAY HAVEN) FOR THE PROCUREMENT OF FOOD AND ACCOMMODATION FOR THE TRAINING WORKSHOP ON CHILD PROTECTION COMMITTEE FUNCTIONALITY 2024

WHEREAS, DepEd Regional Office IV-A CALABARZON has undertaken procurement of FOOD AND ACCOMMODATION for the TRAINING WORKSHOP ON CHILD PROTECTION COMMITTEE FUNCTIONALITY 2024 on SEPTEMBER 25-27, 2024;

WHEREAS, the Approved Budget for the Contract (ABC) is THREE HUNDRED THOUSAND PESOS (Php300,000.00);

WHEREAS, Section 53.9 of the 2016 Revised Implementing Rules and Regulations (R-IRR) of Republic Act 9184, otherwise known as the "Government Procurement Reform Act of 2003", allows an agency to resort to Small Value Procurement as alternative method of procurement where the amount involved does not exceed the threshold amount of One Million Pesos (Php1,000,000.00) as prescribed in Annex "H" thereof;

WHEREAS, the Request for Quotation (RFQ) was posted in the Philippine Government Electronic Procurement System (PhilGEPS), office website and conspicuous bulletin board in the premises of this Office from September 4, 2024 to September 9, 2024 at 9:00 a.m.;

WHEREAS, RFQs were sent to at least three (3) prospective suppliers as follows: (1) Sunny Glades Properties Corporation (Tagaytay Haven); (2) Whitewoods Convention and Leisure Hotel; and (3) Tagaytay Automart Inc. (Tagaytay Country Hotel);

WHEREAS, three (3) suppliers submitted their respective proposals before the deadline for the submission of quotations, offering the following financial quotations, as read:


