**BAC RESOLUTION**

**RECOMMENDING TO THE HEAD OF THE PROCURING ENTITY THE AWARD OF CONTRACT TO THE BAYLEAF HOTEL (THE BAYLEAF CAVITE) FOR THE PROCUREMENT OF FOOD WITH CONFERENCE HALL FOR THE CONSULTATIVE MEETING IN THE PREPARATIONS FOR THE 2024 REGIONAL RESEARCH CONFERENCE**

**WHEREAS**, DepEd Regional Office IV-A CALABARZON has undertaken procurement of **FOOD WITH CONFERENCE HALL** for the **CONSULTATIVE MEETING IN THE PREPARATIONS FOR THE 2024 REGIONAL RESEARCH CONFERENCE** on **SEPTEMBER 18, 2024**;

**WHEREAS**, the Approved Budget for the Contract (ABC) is **FORTY-TWO THOUSAND PESOS (Php42,000.00)**;

**WHEREAS**, Section 53.9 of the 2016 Revised Implementing Rules and Regulations (R-IRR) of Republic Act 9184, otherwise known as the "Government Procurement Reform Act of 2003", allows an agency to resort to Small Value Procurement as alternative method of procurement where the amount involved does not exceed the threshold amount of One Million Pesos (Php1,000,000.00) as prescribed in Annex "H" thereof;

**WHEREAS**, the Request for Quotation (RFQ) was posted in the office website and conspicuous bulletin board in the premises of this Office starting on September 4, 2024 to September 9, 2024 at 9:00 a.m.;

**WHEREAS**, RFQs were sent to at least three (3) prospective suppliers as follows: (1) Caliv Resort and Development Corporation (Villa Excellance Beach and Wavepool Resort); (2) Tagaytay Automart Inc. - Tagaytay Country Hotel and (3) Marawi Leisure Park Inc. (Tanza Oasis Hotel and Resort);

**WHEREAS**, one (1) supplier submitted their respective proposal: **THE BAYLEAF HOTEL (THE BAYLEAF CAVITE)** in the amount **FORTY-TWO THOUSAND PESOS (Php42,000.00)** Thus, **THE BAY LEAF HOTEL (THE BAYLEAF CAVITE)** is declared as the lone bidder;

**WHEREAS**, after review and deliberation on the proposal, **THE BAYLEAF HOTEL (THE BAYLEAF CAVITE)** complied with the requirements and declared as the single Calculated and Responsive Quotation (LCRQ);

**NOW, THEREFORE**, the **BAC** hereby **RESOLVES** as it hereby **RESOLVED** to **RECOMMEND** to the Regional Director, as the Head of the Procuring Entity, the award of the project to **THE BAYLEAF HOTEL (THE BAYLEAF CAVITE)** in the amount **FORTY-TWO THOUSAND PESOS (Php42,000.00)**.
