## MONITORING AND VALIDATION OF SPECIAL NEEDS EDUCATION (SNED) PROGRAM IMPLEMENTATION AND INCLUSIVE LEARNING RESOURCE CENTERS

## To Schools Division Superintendents

- 1. Pursuant to RA 11650, also known as an act "Instituting a Policy of Inclusion and Services for Learners with Disabilities in Support of Inclusive Education Act" and DO 44, s2021 and DO 09, s2024, this office will conduct the Regional Monitoring and Validation of Special Needs Education (SNED) Program Implementation and Inclusive Learning Resource Centers and other Special Curricular Programs on October 21-25, 2024.
- 2. The objective of this activity is to adhere the mandate of DO 44, s. 2021, Sec. M&E, that the RO-CLMD and SDO-CID are expected to "conduct M&E to all schools to ensure that support systems are in place in the implementation of the SNED programs and services".

- 4. The travel, board and lodging, and other incidental expenses of the RO personnel shall be charged to the FY 2023 SNED Continuing Fund while SDO Personnel travel and incidental expenses of SDO Personnel shall be charged to the downloaded SNED PSF 2024. Should there be an insufficiency in the amount downloaded for the travel expenses of the participants, the deficit shall be charged against local funds or other sources of funds, subject to usual accounting and auditing rules and regulations.
