To **Schools Division Superintendents**

1. In line with the DepEd's continuous efforts to ensure the efficient distribution and utilization of procured Self-Learning Modules (SLMs) and Supplementary Learning Resources (SLRs), the Regional Office IV-A CALABARZON will conduct Regional Monitoring and Validation on the Distribution and Utilization of Procured Self Learning Modules (SLMs) and Supplementary Learning Resources (SLRs) for Library Hubs from October to December 2024.
