## ENHANCING THE CAPACITY OF THE REGIONAL GAD LEARNING FACILITATORS

  - 1. The lack of a regional pool of learning facilitators on Gender and Development (GAD) in DepEd CALABARZON prompted the Regional GAD Focal Point System (GFPS) to launch a training program in 2021 to establish such a pool. Since then, the Regional GFPS has been implementing capacity-building programs to prepare its members to serve as resource persons within the region. This initiative also addresses a gap identified in the Gender Mainstreaming and Evaluation Framework (GMEF) tool of the Philippine Commission on Women (PCW), specifically the lack of Regional Pool of GAD Learning Facilitators. To further these efforts, this Office, through the Regional GFPS, will conduct a capacity enhancement program for Regional GAD Learning Facilitators on October 16-18, 2024, at Soleste Suites, Quezon City.
  - 2. The ongoing capacity enhancement efforts aim to strengthen the core competencies of the identified Regional GAD learning facilitators, who will be engaged to deliver core GAD messages within the organization.
  - 3. The participants identified in this activity are members of GAD Focal Point System of the regional office and schools division offices, and those personnel who have attended various capacity development programs on gender and development provided by the regional office. Please refer to the attached enclosure for the list of the attendees.
  - 4. The first meal to be served is breakfast on Day 1, and the last meal to be served is p.m. snack on Day 3. Likewise, the participants are encouraged to bring their water tumblers, laptop, and extension cord.
  - 5. Expenses relative to the conduct of the activities such as food and accommodation of the regional office participants, honorarium of the invited speakers, supplies and materials, travel expenses shall be charged against the local funds/GAD fund while expenses of the SDO participants relative to their
