BAC RESOLUTION

RECOMMENDING TO THE HEAD OF PROCURING ENTITY THE AWARD OF CONTRACT TO HAWKSTOW CONSTRUCTION & DEVELOPMENT FOR THE PROCUREMENT OF REPAIR, REHABILITATION, AND MAINTENANCE OF NATIONAL EDUCATORS ACADEMY OF THE PHILIPPINES (NEAP) FACILITY (REGION IV-A CALABARZON) (ROIVA-2024-06)

WHEREAS, on August 7, 2024, DepEd Regional Office IV-A CALABARZON has advertised its procurement activity for the procurement of **REPAIR, REHABILITATION, AND MAINTENANCE OF NATIONAL EDUCATORS ACADEMY OF THE PHILIPPINES (NEAP) FACILITY (REGION IV-A CALABARZON)** with reference number **ROIVA-2024-06** in the PhilGEPS website, office website, and in conspicuous bulletin board of the Office;

WHEREAS, the Approved Budget for the Contract (ABC) is **TWENTY MILLION NINE HUNDRED NINETY-SIX THOUSAND THREE HUNDRED FORTY-TWO PESOS AND 81/100 (Php 20,966,342.81)**;

WHEREAS, in response to the Invitation to Bid for the above mentioned procurement, the BAC received two (2) sealed bids, offering the following financial bids, as read:

WHEREAS, using the checklist of required documents and taking into account the non-discretionary "Pass or Fail Criterion", the BAC found that **NMDC CONSTRUCTION CORPORATION** has found to be non-responsive and/or non-compliant for failure to submit the prescribed Omnibus Sworn Statement template as provided in the Bidding Documents;

WHEREAS, as per NPM No. 121-2014 of the Government Procurement Policy Board (GPPB) dated November 12, 2024 provides that "failure of the bidder to comply with the prescribed Omnibus Sworn Statement template despite this being included in the Philippine Bidding Document is a cause for the bidder's ineligibility or disqualification";

WHEREAS, using the checklist of required documents and taking into account the non-discretionary "Pass or Fail Criterion", the BAC found that **HAWKSTOW**

3. **To RECOMMEND** to the Regional Director, as the Head of the Procuring Entity, the **award of contract to HAWKSTOW CONSTRUCTION & DEVELOPMENT** for the procurement of Repair, Rehabilitation, and Maintenance of National Educators Academy of the Philippines (NEAP) Facility (Region IV-A CALABARZON) (ROIVA-2024-06).


