BAC RESOLUTION

RECOMMENDING TO THE HEAD OF THE PROCURING ENTITY THE AWARD OF CONTRACT TO GOD'S TREASURE ENTERPRISES FOR THE PROCUREMENT OF CATERING SERVICES FOR THE CLMD PROGRAM REVIEW AND STRATEGIC PRE-PLANNING FOR 2025

WHEREAS, DepEd Regional Office IV-A CALABARZON has undertaken procurement of **CATERING SERVICES** for the **CLMD PROGRAM REVIEW AND STRATEGIC PRE-PLANNING FOR 2025** on **OCTOBER 22-24, 2024**;

WHEREAS, the Approved Budget for the Contract (ABC) is **THIRTY THOUSAND SIX HUNDRED PESOS (Php30,600.00)**;

WHEREAS, Section 53.9 of the 2016 Revised Implementing Rules and Regulations (R-IRR) of Republic Act 9184, otherwise known as the "Government Procurement Reform Act of 2003", allows an agency to resort to Small Value Procurement as alternative method of procurement where the amount involved does not exceed the threshold amount of One Million Pesos (Php1,000,000.00) as prescribed in Annex "H" thereof;

WHEREAS, the Request for Quotation (RFQ) was posted in the office website and conspicuous bulletin board in the premises of this Office from October 1, 2024 to October 4, 2024 at 9:00 a.m.;

WHEREAS, RFQs were sent to at least three (3) prospective suppliers as follows: (1) God's Treasure Enterprises; (2) DepEd Region IV-A CALABARZON Multi-Purpose Cooperative; and (3) Focal Managing Loop Inc.;

WHEREAS, one (1) Supplier submitted its proposal: **GOD'S TREASURE ENTERPRISES** in the amount of **TWENTY-NINE THOUSAND EIGHT HUNDRED THIRTY-FIVE PESOS (Php29,835.00)**. Thus, **GOD'S TREASURE ENTERPRISES** is declared as the lone bidder;

WHEREAS, after review and deliberation on the proposal, **GOD'S TREASURE ENTERPRISES** complied with the requirements and declared as the Single Calculated and Responsive Quotation (SCRQ);

NOW, THEREFORE, the **BAC** hereby **RESOLVES** as it hereby **RESOLVED** to **RECOMMEND** to the Regional Director, as the Head of the Procuring Entity, the award of the project to **GOD'S TREASURE ENTERPRISES** in the amount of **TWENTY-NINE THOUSAND EIGHT HUNDRED THIRTY-FIVE PESOS (Php29,835.00)**.


