BAC RESOLUTION

RECOMMENDING TO THE HEAD OF THE PROCURING ENTITY THE AWARD OF CONTRACT TO SUNRISE RIDGE CORPORATION (SOLESTE SUITES) FOR THE WRITESHOP ON DECISION AND RESOLUTION WRITING

WHEREAS, DepEd Regional Office IV-A CALABARZON has undertaken procurement of **FOOD AND ACCOMMODATION** for the **WRITESHOP ON DECISION AND RESOLUTION WRITING** on **DECEMBER 2-6, 2024**;

WHEREAS, the Approved Budget for the Contract (ABC) is **TWO HUNDRED FIFTY THOUSAND PESOS (Php250,000.00)**;

WHEREAS, Section 53.9 of the 2016 Revised Implementing Rules and Regulations (R-IRR) of Republic Act 9184, otherwise known as the "Government Procurement Reform Act of 2003", allows an agency to resort to Small Value Procurement as alternative method of procurement where the amount involved does not exceed the threshold amount of One Million Pesos (Php1,000,000.00) as prescribed in Annex "H" thereof;

WHEREAS, the Request for Quotation (RFQ) was posted in the Philippine Government Electronic Procurement System (PhilGEPS), office website and conspicuous bulletin board in the premises of this Office starting on October 18, 2024 to October 23, 2024 at 9:00 a.m.;

WHEREAS, RFQs were sent to six (6) prospective suppliers as follows: (1) Sunrise Ridge Corporation (Soleste Suites); (2) Marawi Leisure Park Inc. (Tanza Oasis Hotel and Resort); (3) Caliv Resort and Development Corp. (Villa Excellance Beach and Wavepool Resort); (4) The Bayleaf Hotel-Cavite; (5) Red Hotel; and (6) Madison 101 Inc.;

WHEREAS, one (1) Supplier submitted its proposal: **SUNRISE RIDGE CORPORATION (SOLESTE SUITES)** in the amount of **TWO HUNDRED THIRTY-ONE THOUSAND TWO HUNDRED FIFTY PESOS (Php231,250.00)**. Thus, **SUNRISE RIDGE CORPORATION (SOLESTE SUITES)** is declared as the lone bidder;

WHEREAS, after review and deliberation on the proposals, **SUNRISE RIDGE CORPORATION (SOLESTE SUITES)** complied with the requirements and is hereby declared as the Single Calculated and Responsive Quotation (SCRQ);

NOW, THEREFORE, the **BAC** hereby **RESOLVES** as it hereby **RESOLVED** to **RECOMMEND** to the Regional Director, as the Head of the Procuring Entity, the award of the project to **SUNRISE RIDGE CORPORATION (SOLESTE SUITES)** in the amount **TWO HUNDRED THIRTY-ONE THOUSAND TWO HUNDRED FIFTY PESOS (Php231,250.00)**.
