WHEREAS, DepEd Regional Office IV-A CALABARZON has undertaken procurement of **CATERING SERVICES** for the **PROGRAM ON WELFARE FOR THE EMPLOYEES OF REGIONAL OFFICE (POWER-O) AWARDING CEREMONY FOR THE 2024 INTERCOLORS SPORTS ACTIVITIES** on **NOVEMBER 14, 2024**;

WHEREAS, the Approved Budget for the Contract (ABC) is **NINETY-TWO THOUSAND FIVE HUNDRED PESOS (Php92,500.00)**;

WHEREAS, Section 53.9 of the 2016 Revised Implementing Rules and Regulations (R-IRR) of Republic Act 9184, otherwise known as the “Government Procurement Reform Act of 2003”, allows an agency to resort to Small Value Procurement as alternative method of procurement where the amount involved does not exceed the threshold amount of One Million Pesos (Php1,000,000.00) as prescribed in Annex “H” thereof;

WHEREAS, the Request for Quotation (RFQ) was posted in the Philippine Government Electronic Procurement System (PhilGEPS), office website and conspicuous bulletin board in the premises of this Office from October 31, 2024 to November 7, 2024 at 9:00 a.m.;

WHEREAS, RFQs were sent to at least (3) prospective suppliers as follows: (1) Focal Managing Loop; (2) God’s Treasure Enterprises; (3) and DepEd Region IV-A CALABARZON Multipurpose Cooperative;
