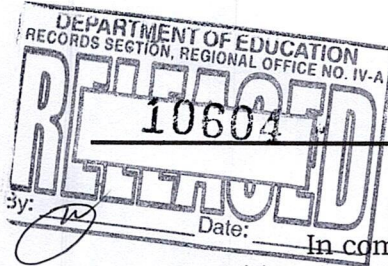

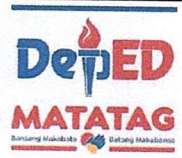

In reference to the DepEd Memorandum OUOPS-2024-05-04956¹, this Office, through the Field Technical Assistance Division, requests for the implementation of the Learner Rights and Protection on Wheels on July 29, 2024.

This activity aims to ensure the protection and upholding of the rights of learners across the Philippines and aims to bring educational rights awareness and protection services to create a safer and more inclusive learning environment for all learners.

Relative to this, the Division Learner Rights and Protection Focal Person shall compose the Learner Rights and Protection Team. The Division LRP Focal shall also identify 4 schools to be visited, including but not limited to the reported cases received by the Learners TeleSafe Contact Center Helpline (LTCCH).

Furthermore, as stated in the DepEd Memorandum, the SDO shall submit a report relative to its conduct to the Regional Office, subsequently to the LRPO email on or before **August 1, 2024**, to monitor the program's progress and effectiveness.

Attached is the DepEd Memorandum for perusal and reference.

Travel and other related expenses of the participants shall be charged against the local funds subject to the usual accounting and auditing rules and regulations.
