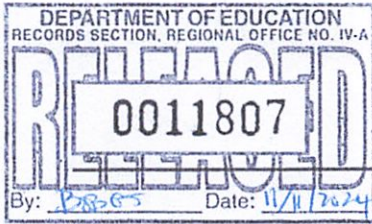

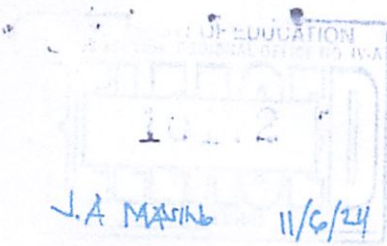

**2024 VIRTUAL CONVERGENCE OF RO AND
SDO COUNTERPARTS ON PUBLIC AND

To: **All Schools Division Superintendents**
Private Schools Administrators

1. This Office through the Quality Assurance Division (QAD) announces the conduct of the **2024 Virtual Convergence of RO and SDO Counterparts on Public and Private School Processes** which will be held on November 12-13, 2024 through a virtual platform. The link shall be provided through the SDO Counterpart.
2. The activity aims to reiterate the guidelines and relative provisions of the following processes:
 - a. government recognition, new and renewal of government permit application;
 - b. establishment, merging, conversion, naming/renaming of public schools and separation of public schools annexes in basic education (DO 40 s. 2014);
 - c. transfer of learners from International School to Philippine Regular Private Schools;
 - d. acknowledgment of tuition fees and other school fees application; and
 - e. Guidelines on the Implementation of Senior High School Voucher Program DO 20, s. 2023.
3. The participants in this activity are the CID Chiefs, SGOD Chiefs, SDO EPS in-charge of private and public schools, Public Schools District Supervisors (PSDSs) and Planning Officers. Also, the Public School Heads, Private School Heads and School Registrars are encouraged to participate in this activity. On the other hand, ICT personnel shall be in-charge of the virtual technical concerns and all the Quality Assurance Division (QAD) personnel shall serve as the technical working committee.
