RECOMMENDING TO THE HEAD OF THE PROCURING ENTITY THE AWARD OF CONTRACT TO MANILA GRAND OPERA HOTEL INC. FOR THE PROCUREMENT OF FOOD AND ACCOMMODATION FOR THE FINALIZATION WORKSHOP FOR THE LOCALIZED REFERRAL SYSTEM ON MENTAL HEALTH PSYCHOSOCIAL SUPPORT (MHPSS) INTERVENTIONS AND ADOLESCENT REPRODUCTIVE HEALTH

WHEREAS, DepEd Regional Office IV-A CALABARZON has undertaken procurement of **FOOD AND ACCOMMODATION** for the **FINALIZATION WORKSHOP FOR THE LOCALIZED REFERRAL SYSTEM ON MENTAL HEALTH PSYCHOSOCIAL SUPPORT (MHPSS) INTERVENTIONS AND ADOLESCENT REPRODUCTIVE HEALTH** on **NOVEMBER 13-15, 2024**;

WHEREAS, the Approved Budget for the Contract (ABC) is **THREE HUNDRED SIXTY-TWO THOUSAND PESOS (Php362,000.00)**;

WHEREAS, Section 53.9 of the 2016 Revised Implementing Rules and Regulations (R-IRR) of Republic Act 9184, otherwise known as the "Government Procurement Reform Act of 2003", allows an agency to resort to Small Value Procurement as alternative method of procurement where the amount involved does not exceed the threshold amount of One Million Pesos (Php1,000,000.00) as prescribed in Annex "H" thereof;

WHEREAS, the Request for Quotation (RFQ) was posted in the Philippine Government Electronic Procurement System (PhilGEPS), office website and conspicuous bulletin board in the premises of this Office starting on October 7, 2024 to October 11, 2024 at 9:00 a.m.;

WHEREAS, RFQs were sent to six (6) prospective suppliers as follows: (1) Red Hotel; (2) Jade Hotel and Suites Corporation; (3) Madison 101 Inc.; (4) Ramada by Wyndham Manila Central; (5) Berjaya Makati Hotel Philippines; and (6) Sequoia Manila Bay;

WHEREAS, two (2) suppliers submitted their respective proposals before the deadline for the submission of quotations, offering the following financial quotations, as read:
