RECOMMENDING TO THE HEAD OF THE PROCURING ENTITY THE AWARD OF CONTRACT TO THE AXIAA HOTEL FOR THE LEASE OF VENUE WITH FOOD AND ACCOMMODATION FOR THE WORKSHOP ON THE FINALIZATION OF CONTEXTUALIZED LESSON PLAN EXEMPLARS FOR MULTIGRADE TEACHING FOR 3RD AND 4TH QUARTERS

WHEREAS, DepEd Regional Office IV-A CALABARZON has undertaken procurement of **LEASE OF VENUE WITH FOOD AND ACCOMMODATION** for the **WORKSHOP ON THE FINALIZATION OF CONTEXTUALIZED LESSON PLAN EXEMPLARS FOR MULTIGRADE TEACHING FOR 3RD AND 4TH QUARTERS** on **NOVEMBER 21-24, 2024**;

WHEREAS, the Approved Budget for the Contract (ABC) is **EIGHT HUNDRED FIFTY-TWO THOUSAND PESOS (Php852,000.00)**;

WHEREAS, Rule XVI, Section 48.2 of the IRR of R.A. 9184, otherwise known as the “Government Procurement Reform Act of 2003” provides the general rule that public bidding is the general mode of procurement. However, the same section allows procuring entities to resort to alternative methods of procurement such as Negotiated Procurement subject to the approval of the Head of the Procuring Entity;

WHEREAS, Rule XVI, Section 53.10 of the IRR of R.A. 9184 allows Negotiated Procurement under Lease of Real Property and Venue as a mode of procurement subject to the approval of the Head of Procuring Entity;

WHEREAS, the BAC thru its Secretariat, initiated the procurement activity by requesting for quotation to four (4) prospective suppliers as follows: (1) Red Hotel Inc.; (2) Sequoia Manila Bay; (3) Axiaa Hotel; and (4) Ramada by Wyndham Manila Central

WHEREAS, one (1) supplier submitted its proposal before the deadline for the submission of quotations, offering the following financial bid, as read:

WHEREAS, On November 5, 2024, the end-user submitted a report for the ocular inspection at **AXIAA HOTEL** with the attached rating of the venue in accordance with the technical specification pursuant to Appendix “B” of Annex “H” of the Consolidated Guideline for the Alternative Methods of Procurement;

WHEREAS, based on the result of the ocular inspection reflected in the Rating Factors and Determination of Reasonableness of Rental Rate **AXIAA HOTEL** and rated with the score of **93.95**;
