WHEREAS, DepEd Region IV-A CALABARZON intends to procure Printing and Delivery of Storybook Packages for DepEd Region IV-A CALABARZON;

WHEREAS, the Approved Budget for the Contract (ABC) is SIXTY-SEVEN MILLION SEVEN HUNDRED FOUR THOUSAND TWO HUNDRED SIXTY-SEVEN PESOS (Php67,704,267.00);

WHEREAS, on November 7, 2024, the BAC, BAC Secretariat, TWG and representative from the End-User conducted a pre-procurement conference to discuss the said allotment for the printing and delivery of Storybook Packages;

WHEREAS, on November 12, 2024, the BAC sent Request for Quotations (RFQs) to APO Production Unit, Inc. (APO), a Recognized Government Printers (RGPs);

WHEREAS, in response APO submitted its proposal before the deadline for the submission of bids, offering the financial bids, as read:

with the total amount of SIXTY-SEVEN MILLION SEVEN HUNDRED THREE HUNDRED SEVENTY-SIX THOUSAND NINE PESOS AND 20/100 (Php67,703,976.20).
