RECOMMENDING TO THE HEAD OF THE PROCURING ENTITY THE AWARD OF CONTRACT TO TAGAYTAY COUNTRY HOTEL FOR THE PROCUREMENT OF FOOD AND ACCOMMODATION FOR THE UNIVERSAL PREVENTION CURRICULUM (UPC) FOR SUBSTANCE ABUSE CALABARZON RE-ECHO TRAINING OF MODULE 5: SCHOOL BASED PREVENTION INTERVENTIONS

WHEREAS, DepEd Regional Office IV-A CALABARZON has undertaken procurement of FOOD AND ACCOMMODATION for the UNIVERSAL PREVENTION CURRICULUM (UPC) FOR SUBSTANCE ABUSE CALABARZON RE-ECHO TRAINING OF MODULE 5: SCHOOL BASED PREVENTION INTERVENTIONS on **DECEMBER 16-20, 2024;**

WHEREAS. the Approved Budget for the Contract (ABC) is EIGHT HUNDRED NINETY THOUSAND PESOS (Php890,000.00);

WHEREAS, Section 53.9 of the 2016 Revised Implementing Rules and Regulations (R-IRR) of Republic Act 9184, otherwise known as the "Government Procurement Reform Act of 2003", allows an agency to resort to Small Value Procurement as alternative method of procurement where the amount involved does not exceed the threshold amount of One Million Pesos (Php1,000,000.00) as prescribed in Annex "H" thereof;

WHEREAS, the Request for Quotation (RFQ) was posted in the Philippine Government Electronic Procurement System (PhilGEPS), office website and conspicuous bulletin board in the premises of this Office from November 14, 2024 to November 19, 2024 at 9:00 a.m.;

WHEREAS, RFOs were sent to at least three (3) prospective suppliers as follows: (1) Tagaytay Country Hotel; (2) Sunny Glades Properties Corp. (Tagaytay Haven Hotel); and (3) Splendido Tagaytay Hotel Inc.

WHEREAS, three (3) suppliers submitted their respective proposals before the deadline for the submission of quotations, offering the following financial quotations, as read:


