**BAC RESOLUTION**

**RECOMMENDING TO THE HEAD OF PROCURING ENTITY THE AWARD OF CONTRACT TO GOD'S TREASURE ENTERPRISES FOR THE PROCUREMENT OF CATERING SERVICES FOR THE ORAL REHABILITATION FOR THE DEPED REGIONAL OFFICE EMPLOYEES UNDER THE BALIK NGITI PROJECT**

**WHEREAS**, DepEd Regional Office IV-A CALABARZON has undertaken procurement of **CATERING SERVICES** for the **ORAL REHABILITATION FOR THE DEPED REGIONAL OFFICE EMPLOYEES UNDER THE BALIK NGITI PROJECT** on **DECEMBER 9-13, 2024** and **DECEMBER 16-17, 2024**;

**WHEREAS**, the Approved Budget for the Contract (ABC) is **ONE HUNDRED THIRTEEN THOUSAND FOUR HUNDRED PESOS (Php113,400.00)**;

**WHEREAS**, Section 53.9 of the 2016 Revised Implementing Rules and Regulations (R-IRR) of Republic Act 9184, otherwise known as the "Government Procurement Reform Act of 2003", allows an agency to resort to Small Value Procurement as alternative method of procurement where the amount involved does not exceed the threshold amount of One Million Pesos (Php1,000,000.00) as prescribed in Annex "H" thereof;

**WHEREAS**, the Request for Quotation (RFQ) was posted in the Philippine Government Electronic Procurement System, office website and conspicuous bulletin board in the premises of this Office from November 25, 2024 to November 29, 2024 at 9:00 a.m.;

**WHEREAS**, RFQs were sent at least three (3) prospective suppliers as follows: (1) Focal Managing Loop; (2) God's Treasure Enterprises; and (3) DepEd Region IV-A CALABARZON Multipurpose Cooperative;

**WHEREAS**, two (2) suppliers submitted their respective proposals before the deadline for the submission of quotations, offering the following financial quotations, as read:
