**RECOMMENDING TO THE HEAD OF THE PROCURING ENTITY THE AWARD OF CONTRACT TO SUNRISE RIDGE CORPORATION (SOLESTE SUITES) FOR THE PROCUREMENT OF FOOD AND ACCOMMODATION FOR THE PROGRAM DEVELOPMENT AND PERFORMANCE APPRAISAL FOR FY 2024 OF ESSD ACTIVITIES (PHASE II)**

**WHEREAS**, DepEd Regional Office IV-A CALABARZON has undertaken procurement of **FOOD AND ACCOMMODATION** for the **PROGRAM DEVELOPMENT AND PERFORMANCE APPRAISAL FOR FY 2024 OF ESSD ACTIVITIES (PHASE II)** on **DECEMBER 19-20, 2024**;

**WHEREAS**, the Approved Budget for the Contract (ABC) is **SEVENTY-TWO THOUSAND PESOS (Php72,000.00)**;

**WHEREAS**, Section 53.9 of the 2016 Revised Implementing Rules and Regulations (R-IRR) of Republic Act 9184, otherwise known as the "Government Procurement Reform Act of 2003", allows an agency to resort to Small Value Procurement as alternative method of procurement where the amount involved does not exceed the threshold amount of One Million Pesos (Php1,000,000.00) as prescribed in Annex "H" thereof;

**WHEREAS**, the Request for Quotation (RFQ) was posted in the Philippine Government Electronic Procurement System (PhilGEPS), office website and conspicuous bulletin board in the premises of this Office starting on November 29, 2024 to December 4, 2024 at 9:00 a.m.;

**WHEREAS**, RFQs were sent to four (4) prospective suppliers as follows: (1) Madison 101 Inc.; (2) Red Hotel; (3) Sunrise Ridge Corporation (Soleste Suites); and (4) The First Villa Cristina Hotel & Resort Inc.;

**WHEREAS**, one (1) Supplier submitted its proposal: **SUNRISE RIDGE CORPORATION (SOLESTE SUITES)** in the amount of **SIXTY-EIGHT THOUSAND FOUR HUNDRED PESOS (Php68,400.00)**. Thus, **SUNRISE RIDGE CORPORATION (SOLESTE SUITES)** is declared as the lone bidder;

**WHEREAS**, after review and deliberation on the proposals, **SUNRISE RIDGE CORPORATION (SOLESTE SUITES)** complied with the requirements and is hereby declared as the Single Calculated and Responsive Quotation (SCRQ);

**NOW, THEREFORE**, the **BAC** hereby **RESOLVES** as it hereby **RESOLVED** to **RECOMMEND** to the Regional Director, as the Head of the Procuring Entity, the award of the project to **SUNRISE RIDGE CORPORATION (SOLESTE SUITES)** in the amount **SIXTY-EIGHT THOUSAND FOUR HUNDRED PESOS (Php68,400.00)**.


