RECOMMENDING TO THE HEAD OF THE PROCURING ENTITY THE AWARD OF CONTRACT TO FIRST STA. ROSA HOTEL CORPORATION (EL CIELITO HOTEL - STA. ROSA) FOR THE PROCUREMENT OF FOOD AND ACCOMMODATION FOR THE REGIONAL TRAINING OF CORE TRAINERS IN CAMPUS **JOURNALISM**

WHEREAS, DepEd Regional Office IV-A CALABARZON has undertaken procurement of FOOD AND ACCOMMODATION for the REGIONAL TRAINING OF CORE TRAINERS IN CAMPUS JOURNALISM on DECEMBER 18-20, 2024;

WHEREAS, the Approved Budget for the Contract (ABC) is FIVE HUNDRED NINETY-FOUR THOUSAND PESOS (Php594,000.00);

WHEREAS, Section 53.9 of the 2016 Revised Implementing Rules and Regulations (R-IRR) of Republic Act 9184, otherwise known as the "Government Procurement Reform Act of 2003", allows an agency to resort to Small Value Procurement as alternative method of procurement where the amount involved does not exceed the threshold amount of One Million Pesos (Php1,000,000.00) as prescribed in Annex "H" thereof;

WHEREAS, the Request for Quotation (RFQ) was posted in the Philippine Government Electronic Procurement System (PhilGEPS), office website and conspicuous bulletin board in the premises of this Office starting on November 20, 2024 to November 25, 2024 at 9:00 a.m.;

WHEREAS, RFQs were sent to at least three (3) prospective suppliers as follows: (1) First Sta. Rosa Hotel Corporation (El Cielito Hotel - Sta. Rosa); (2) Caliraya Resort Club, Inc.; and (3) Alprops Management and Realty Inc. (Monte Vista Hotsprings & Conference Resort);

WHEREAS, two (2) suppliers submitted their respective proposals before the deadline for the submission of quotations, offering the following financial quotations, as read:


