**RECOMMENDING TO THE HEAD OF THE PROCURING ENTITY THE AWARD OF CONTRACT TO FIRST STA ROSA HOTEL CORPORATION (EL CIELITO HOTEL- STA ROSA) FOR THE PROCUREMENT OF FOOD AND ACCOMMODATION FOR THE REGIONAL TRAINING ON BROADCAST AND DIGITAL CAMPUS JOURNALISM**

**WHEREAS**, DepEd Regional Office IV-A CALABARZON has undertaken procurement of **FOOD AND ACCOMMODATION** for the **REGIONAL TRAINING ON BROADCAST AND DIGITAL CAMPUS JOURNALISM** on **DECEMBER 3-5, 2024**;

**WHEREAS**, the Approved Budget for the Contract (ABC) is **THREE HUNDRED SIX THOUSAND PESOS (Php306,000.00)**;

**WHEREAS**, Section 53.9 of the 2016 Revised Implementing Rules and Regulations (R-IRR) of Republic Act 9184, otherwise known as the "Government Procurement Reform Act of 2003", allows an agency to resort to Small Value Procurement as alternative method of procurement where the amount involved does not exceed the threshold amount of One Million Pesos (Php1,000,000.00) as prescribed in Annex "H" thereof;

**WHEREAS**, the Request for Quotation (RFQ) was posted in the Philippine Government Electronic Procurement System (PhilGEPS), office website and conspicuous bulletin board in the premises of this Office from October 16, 2024 to October 21, 2024 at 9:00 a.m.;

**WHEREAS**, RFQs were sent to at least three (3) prospective suppliers as follows: (1) First Sta Rosa Hotel Corporation (El Cielito Hotel- Sta Rosa); (2) Techno Park Hotel; and (3) Paseo Premiere Hotel;

**WHEREAS**, one (1) Supplier submitted its proposal; **FIRST STA ROSA HOTEL CORPORATION (EL CIELITO HOTEL- STA ROSA)** in the amount of **THREE HUNDRED TWO THOUSAND NINE HUNDRED FORTY PESOS (Php302,940.00)**. Thus, **FIRST STA ROSA HOTEL CORPORATION (EL CIELITO HOTEL- STA ROSA)** is declared as the lone bidder;

**WHEREAS**, after review and deliberation on the proposal, **FIRST STA ROSA HOTEL CORPORATION (EL CIELITO HOTEL- STA ROSA)** complied with the requirements and declared as the Single Calculated and Responsive Quotation (SCRQ);
