**RECOMMENDING TO THE HEAD OF THE PROCURING ENTITY THE AWARD OF CONTRACT TO KRISTIN EDUCATIONAL EXPONENTS PUBLICATIONS, INC. FOR THE PROCUREMENT OF SUPPLY AND DOOR TO DOOR DELIVERY OF REMEDIATION PACKAGES FOR READING PROGRAMS WITH PROJECT IDENTIFICATION NUMBER ROIVA-24-08-LOT 3**

**WHEREAS**, this Office received the Sub-Allotment Release Order (SARO) with number OSEC-4A-24-4045 in the amount of Ninety-Five Million Two Hundred Eighty Thousand Six Hundred Sixty-Nine Pesos (Php95,280,669.00) for the Procurement of Remediation Packages for Reading Programs;

**WHEREAS**, attached in the SARO is the Joint Memorandum dated May 8, 2024 entitled "Guidelines on the Utilization of Downloaded Program Support Funds for Procurement of Remediation Packages for Reading Programs" stating the order of priorities as follows: (a) Serialized Reading Packages; (b) Phonics Activity Sets; and (c) Vocabulary Flash Cards;

**WHEREAS**, on October 1, 2024, the end-user submitted an Authority to Procure with the attached list of titles intended to this project to be procured;

**WHEREAS**, on October 14, 2024, the Bids and Awards Committee (BAC), Technical Working Group (TWG), BAC Secretariat and End-user conducted a pre-procurement conference to discuss the said allotment and approved the bid documents for the procurement of Remediation Packages for Reading Programs;
