WHEREAS, this office received a Joint Memorandum entitled “Updated Guidelines on the Conduct Regional Early Procurement Activities (EPA) for the FY 2025 DepEd Computerization Program (DCP)” stating that Regional Offices (ROs) shall initiate EPA short of award to ensure timely deployment of DCP for CY 2025 and must be noted that contract shall be awarded only upon the approval of General Appropriation Act (GAA) and shall comply with the existing rules and regulation pertinent to the Updated 2016 Revised Implementing Rules and Regulations (IRR) of the RA 9184;

WHEREAS, on November 7, 2024, the Bids and Awards Committee (BAC), Technical Working Group (TWG), BAC Secretariat and End-user conducted a pre-procurement conference to discuss the said allotment and approved the bid documents for the procurement of supply and door to door delivery of Smart TV package (STV), Laptop for Teaching (L4T) and Laptop for Non-Teaching (L4NT) for DepEd Region IV-A CALABARZON;
