**BAC RESOLUTION**

**RECOMMENDING TO THE HEAD OF THE PROCURING ENTITY THE AWARD OF CONTRACT TO XITRIX COMPUTER CORPORATION FOR THE EARLY PROCUREMENT OF SUPPLY AND DOOR TO DOOR DELIVERY OF SMART TV PACKAGE (STV), LAPTOP FOR TEACHING (L4T) AND LAPTOP FOR NON-TEACHING (L4NT) FOR DEPED REGION IV-A CALABARZON – LOT 1**

**WHEREAS**, this Office received an Indicative Regional Physical and Financial Allocation for the conduct of Early Procurement Activities (EPA) of the following:

**WHEREAS**, this office received a Joint Memorandum entitled “Updated Guidelines on the Conduct of the Regional Early Procurement Activities (EPA) for the FY 2025 DepEd Computerization Program (DCP)” stating that Regional Offices (ROs) shall initiate EPA short of award to ensure timely deployment of DCP for CY 2025 and must be noted that contract shall be awarded only upon the approval of General Appropriation Act (GAA) and shall comply with the existing rules and regulation pertinent to the Updated 2016 Revised Implementing Rules and Regulations (IRR) of the RA 9184;

**WHEREAS**, on November 7, 2024, the Bids and Awards Committee (BAC), Technical Working Group (TWG), BAC Secretariat and End-user conducted a pre-procurement conference to discuss the said allotment and approved the bid documents for the procurement of supply and door to door delivery of Smart TV package (STV), Laptop for Teaching (L4T) and Laptop for Non-Teaching (L4NT) for DepEd Region IV-A CALABARZON;

**WHEREAS**, on November 14, 2024, DepEd Regional Office IV-A CALABARZON advertised its procurement activity for the **EARLY PROCUREMENT OF SUPPLY AND DOOR TO DOOR DELIVERY OF SMART TV PACKAGE (STV), LAPTOP FOR TEACHING (L4T) AND LAPTOP FOR NON-TEACHING (L4NT) FOR DEPED REGION IV-A CALABARZON** in the PhilGEPS website, office website, and in conspicuous bulletin board of the Office;

**WHEREAS**, during the bid submission and opening, the BAC received sealed bids, offering the financial bid for **LOT 1**, as read:

**WHEREAS**, using the checklist of required documents and taking into account the non-discretionary "Pass or Fail Criterion", the BAC found that **XITRIX COMPUTER CORPORATION** and **SILICON VALLEY COMPUTER GROUP PHILIPPINES, INC.** have complied with specifications issued by this Office;

**WHEREAS**, upon Post-Qualification proceedings and careful examination, validation and verification of all the eligibility, legal, technical, and financial requirements submitted by **SILICON VALLEY COMPUTER GROUP PHILIPPINES, INC.** as the Lowest Calculated Bid (LCB), it was found to be non-responsive on the following grounds:

- a. Discrepancy on the attached Philippine Standard Safety and Quality Certification Mark issued on May 12, 2023 under the name of TCL Overseas Electronics Hui Zhou, Co. LTD wherein the "An Official Letter on Change of Company Name from TCL Overseas Electronics (HuiZhou), Co., LTD to Moka Technology (Guangdong) Co., Ltd" was approved on May 11, 2021, and;
- b. The Smart TV presented reveal that it did not conform with the specification. The Bluetooth offer is 4+ which is lower than the specification stated in the bid documents which is a minimum of 5.0.

**WHEREAS**, upon Post-Qualification proceedings and careful examination, validation and verification of all the eligibility, legal, technical, and financial requirements submitted by **XITRIX COMPUTER CORPORATION** as the Second Lowest Calculated Bid (LCB), the bid of **XITRIX COMPUTER CORPORATION** has found to be responsive;

**NOW, THEREFORE**, the **BAC** hereby **RESOLVES** as it hereby **RESOLVED**:

1. To **DECLARE** the bid of **SILICON VALLEY COMPUTER GROUP PHILIPPINES, INC.** as ineligible bidder due to non-responsive and/or non-complying of the specification issued by this Office;
2. To **DECLARE** the bid of **XITRIX COMPUTER CORPORATION**, for the Supply and Door to Door Delivery of Smart TV package (STV), Laptop for Teaching (L4T) and Laptop for Non-Teaching (L4NT) for DepEd Region IV-A CALABARZON with project identification number ROIVA-24-10 in the amount of **EIGHTY-SEVEN MILLION TWO HUNDRED FIFTY-NINE THOUSAND TWO**

**HUNDRED PESOS (PHP87,259,200.00) for Lot 1** as the Lowest Calculated and Responsive Bid, in accordance with Section 34.4 of the 2016 Revised Implementing Rules and Regulation (IRR) of RA 9184; and

- To **RECOMMEND** to the Regional Director, as the Head of the Procuring Entity, that the contract for the said project be awarded to **XITRIX COMPUTER CORPORATION** in the above-mentioned amount.
