## **BAC RESOLUTION**

RECOMMENDING TO THE HEAD OF THE PROCURING ENTITY THE AWARD OF CONTRACT TO KRISTIN EDUCATIONAL EXPONENTS PUBLICATIONS, INC. FOR THE PROCUREMENT OF REBIDDING OF SUPPLY AND DOOR TO DOOR DELIVERY OF SUPPLEMENTARY LEARNING RESOURCES (SLRS) FOR LIBRARY HUBS UNDER LOTS 2, 4, 5, 6, 8, 12, 13, 14, 17, 19, 20, 21, 23, 25, 31, 32, 37, 38, 39, 40 AND 42 FOR DEPED REGION IV-A CALABARZON WITH PROJECT IDENTIFICATION NUMBER ROIVA-24-07 - LOT 21

WHEREAS, this Office received the Sub-Allotment Release Order (SARO) with number OSEC-4A-24-2494 in the amount of One Hundred Thirty-Nine Million Six Hundred Thirty-One Thousand Three Hundred Thirty Pesos and 50/100 (Php139,631,330.50) for the Procurement of Supplementary Learning Resources (SLR's) for Library Hubs:

WHEREAS, attached in the SARO is the Joint Memorandum entitled "FY 2024 Fund Allocation and Downloading of Funds for the Provision of Supplementary Learning Resources (SLRs) for Library Hubs" stating that the priority SLRs for reading to be scoped or evaluated and procured shall contain the following themes: (a) Values Education; (b) Health; (c) Peace Education and (d) Gender and Development;

WHEREAS, on November 7, 2024, the Bids and Awards Committee (BAC), Technical Working Group (TWG), BAC Secretariat and End-user conducted a pre-procurement conference to discuss the said allotment and approved the bid documents for the procurement of Rebidding of SLR's for Library Hubs;


