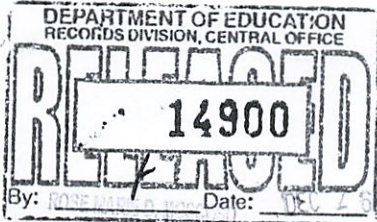

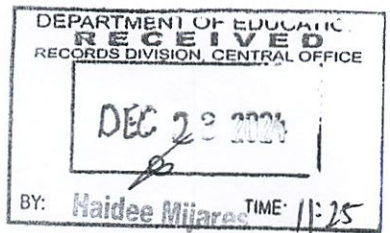

This is in reference to **DM-OUHROD-2024-2302** with the subject “*Deferment of the Procurement Activities for the CY 2024 School Furniture Program*”, which advised that the conduct of the Procurement Activities for CY 2024 School Furniture Program will be temporarily put on hold until further notice.

In view of the series of school visits conducted in response to the recent occurrences of calamities, DepEd deemed it necessary to revisit the design of school furniture. DepEd takes into consideration the Program's primary goal of supplying durable, ergonomically designed, and safe furniture to enhance physical learning spaces in schools. Further, the initiative ensures compliance to Executive Order 879, s. 2010, which directs the use of engineered bamboo for the desk and other furniture requirements of public elementary and secondary schools. Thus, **the conduct of the Procurement Activities for CY 2024 by the field offices is hereby cancelled.**
