CONDUCT OF MONITORING OF THE PRIVATE SCHOOLS PARTICIPATING IN THE GOVERNMENT ASSISTANCE AND SUBSIDIES (GAS) PROGRAM

- 1. Pursuant to DepED Memorandum OUF-2024-0956, Monitoring of Private Schools Participating in the Government Assistance and Subsidies (GAS) Programs and Regional Memorandum no. 907 s. 2024, Regional Guidelines on the Monitoring of the Private Schools Participating in the Government Assistance and Subsidies (GAS) Programs, this Office through the Quality Assurance Division (QAD) issues the Conduct of Monitoring of Private Schools Participating in the Government Assistance and Subsidies (GAS) Programs from February 5 27, 2025.
- The primary objectives of the said activity are to ensure that all the private schools
 participating in the said programs adhere with the provision stated in the
 aforementioned DepEd issuance and ensure accuracy and legitimacy of the GAS
 grants.
- 3. The Regional Monitoring officials shall be composed of the Chief Education Supervisor and Education Program Supervisors (EPSs) from the Quality Assurance Division (QAD) and the Chief and personnel from the Policy Planning and Research Division (PPRD) assigned per SDO Cluster Division as follows.

- 4. The Schools Division Offices (SDOs) shall be composed of SGOD Chief, Planning Officers, SDO PEAC Administrators, Private Schools Coordinators and PSDS per District, to be grouped into 2 teams per SDO except for SDO Batangas Province with 3 teams.
- 5. Attached is the list of Number of Schools Participating in Government Assistance and Subsidies (GAS) Program per SDO. The list will serve as basis in recommending the name of schools per SDO.
- 6. All SDOs are required to provide the list of GAS participating schools which will be the focus of monitoring in compliance with the GAS program. Please submit the recommended list of GAS participating private schools through this link: https://tinyurl.com/GAS-Program-SDO on or before January 30, 2025.
- 7. An orientation shall be conducted on **February 3, 2025** by QAD to guide and inform the RO monitoring team and the SDO counterparts on the monitoring guidelines and procedures including the schedule and target dates of submission of the monitoring report. QAD shall provide a link before the orientation.
- 8. Travel and other expenses of the Regional Office personnel related to the conduct of this activity shall be charged against regional funds while the Schools Division Office shall be charged against local funds subject to the usual accounting and auditing rules and regulations.
