RECOMMENDING TO THE HEAD OF THE PROCURING ENTITY THE AWARD OF CONTRACT TO GOD'S TREASURE ENTERPRISES FOR THE PROCUREMENT OF CATERING SERVICES FOR THE QUALITY ASSURANCE DIVISION (QAD) PROGRAM DEVELOPMENT SESSION WORKSHOP

WHEREAS, DepEd Regional Office IV-A CALABARZON has undertaken procurement of CATERING SERVICES for the QUALITY ASSURANCE DIVISION (QAD) PROGRAM DEVELOPMENT SESSION WORKSHOP on JANUARY 15-16, 2025;

WHEREAS, the Approved Budget for the Contract (ABC) is FOURTEEN THOUSAND FOUR HUNDRED PESOS (Php14,400.00);

WHEREAS, Section 53.9 of the 2016 Revised Implementing Rules and Regulations (R-IRR) of Republic Act 9184, otherwise known as the "Government Procurement Reform Act of 2003", allows an agency to resort to Small Value Procurement as alternative method of procurement where the amount involved does not exceed the threshold amount of One Million Pesos (Php1,000,000.00) as prescribed in Annex "H" thereof;

WHEREAS, the Request for Quotation (RFQ) was posted in the office website and conspicuous bulletin board in the premises of this Office starting on January 3, 2025 to January 7, 2025 at 9:00 a.m.;

WHEREAS, RFQs were sent to at least three (3) prospective suppliers as follows: (1) Focal Managing Loop Inc.; (2) God's Treasure Enterprises; and (3) DepEd Region IV-A CALABARZON Multi-purpose Cooperative;

WHEREAS, one (1) Supplier submitted its proposal; GOD'S TREASURE ENTERPRISES in the amount of FOURTEEN THOUSAND FORTY PESOS (Php14,040.00). Thus, GOD'S TREASURE ENTERPRISES is declared as the lone bidder;

WHEREAS, after review and deliberation on the proposal, **GOD'S TREASURE ENTERPRISES** complied with the requirements and declared as the Single Calculated and Responsive Quotation (SCRQ);

NOW, THEREFORE, the **BAC** hereby **RESOLVES** as it hereby **RESOLVED** to **RECOMMEND** to the Regional Director, as the Head of the Procuring Entity, the award of the project to **GOD'S TREASURE ENTERPRISES** in the amount of **FOURTEEN THOUSAND FORTY PESOS (Php14,040.00).**


