BAC RESOLUTION

RECOMMENDING TO THE HEAD OF PROCURING ENTITY THE AWARD OF CONTRACT TO ALMIGHTY SAVIOUR EDUCATIONAL TOUR AND TRAINING SERVICES FOR THE PROCUREMENT OF RENTAL OF TWO (2) UNITS OF AIR-CON BUSES FOR THE EMPLOYEES ENGAGEMENT TOWARDS THE ENHANCEMENT OF THE PROFESSIONAL CULTURE OF THE REGIONAL OFFICE PERSONNEL

WHEREAS, DepEd Regional Office IV-A CALABARZON has undertaken procurement of **RENTAL OF TWO (2) UNITS OF AIR-CON BUSES** for the **EMPLOYEES ENGAGEMENT TOWARDS THE ENHANCEMENT OF THE PROFESSIONAL CULTURE OF THE REGIONAL OFFICE PERSONNEL** on **JANUARY 29-31, 2025**;

WHEREAS, the Approved Budget for the Contract (ABC) is **ONE HUNDRED THIRTY THOUSAND PESOS (Php130,000.00)**;

WHEREAS, Section 53.9 of the 2016 Revised Implementing Rules and Regulations (R-IRR) of Republic Act 9184, otherwise known as the "Government Procurement Reform Act of 2003", allows an agency to resort to Small Value Procurement as alternative method of procurement where the amount involved does not exceed the threshold amount of One Million Pesos (Php1,000,000.00) as prescribed in Annex "H" thereof;

WHEREAS, the Request for Quotation (RFQ) was posted in the Philippine Government Electronic Procurement System, office website and conspicuous bulletin board in the premises of this Office from January 14, 2025 to January 20, 2025 at 9:00 a.m.;

WHEREAS, RFQs were sent at least three (3) prospective suppliers as follows: (1) God's Treasure Enterprises; (2) Magic-C Transport; and (3) NLCC Tours & Transport;

WHEREAS, one (1) Supplier submitted its proposal; **ALMIGHTY SAVIOUR EDUCATIONAL TOUR AND TRAINING SERVICES** in the amount of **ONE HUNDRED TWENTY-FIVE THOUSAND PESOS (Php125,000.00)**. Thus, **ALMIGHTY SAVIOUR EDUCATIONAL TOUR AND TRAINING SERVICES** is declared as the lone bidder;

WHEREAS, after review and deliberation on the proposal, **ALMIGHTY SAVIOUR EDUCATIONAL TOUR AND TRAINING SERVICES** complied with the requirements and declared as the Single Calculated and Responsive Quotation (SCRQ);

NOW, THEREFORE, the **BAC** hereby **RESOLVES** as it hereby **RESOLVED** to **RECOMMEND** to the Regional Director, as the Head of the Procuring Entity, the award of the project to **ALMIGHTY SAVIOUR EDUCATIONAL TOUR AND TRAINING SERVICES** in the amount of **ONE HUNDRED TWENTY-FIVE THOUSAND PESOS (Php125,000.00)**.
