RECOMMENDING TO THE HEAD OF THE PROCURING ENTITY THE AWARD OF CONTRACT TO AZTECO CORPORATION (AXIAA HOTEL) FOR THE PROCUREMENT OF FOOD AND ACCOMMODATION FOR THE WORKSHOP ON THE DEVELOPMENT OF IMPLEMENTATION AND MONITORING & EVALUATION PLAN FOR DEPED INFORMATION SYSTEMS

WHEREAS, DepEd Regional Office IV-A CALABARZON has undertaken procurement of FOOD AND ACCOMMODATION for the WORKSHOP ON THE DEVELOPMENT OF IMPLEMENTATION AND MONITORING & EVALUATION PLAN FOR DEPED INFORMATION SYSTEMS on JANUARY 22-24, 2025;

WHEREAS, the Approved Budget for the Contract (ABC) is ONE HUNDRED EIGHTY THOUSAND PESOS (Php180,000.00);

WHEREAS, Section 53.9 of the 2016 Revised Implementing Rules and Regulations (R-IRR) of Republic Act 9184, otherwise known as the "Government Procurement Reform Act of 2003", allows an agency to resort to Small Value Procurement as alternative method of procurement where the amount involved does not exceed the threshold amount of One Million Pesos (Php1,000,000.00) as prescribed in Annex "H" thereof;

WHEREAS, the Request for Quotation (RFQ) was posted in the Philippine Government Electronic Procurement System (PhilGEPS), office website and conspicuous bulletin board in the premises of this Office from January 6, 2025 to January 10, 2025 at 9:00 a.m.;

WHEREAS, RFQs were sent to at least three (3) prospective suppliers as follows: (1) Axiaa Hotel; (2) Camelot Hotel; and (3) Sunrise Ridge Corporation (Soleste Suites);

WHEREAS, four (4) suppliers submitted their respective proposals before the deadline for the submission of quotations, offering the following financial quotations, as read:


