RECOMMENDING TO THE HEAD OF THE PROCURING ENTITY THE AWARD OF CONTRACT TO D’GREAT STALLION SECURITY AGENCY, INC. FOR THE PROCUREMENT OF SECURITY SERVICES FOR THE YEAR AT RELC-NEAP MALVAR, BATANGAS

WHEREAS, DepEd Regional Office IV-A CALABARZON has undertaken procurement of **SECURITY SERVICES FOR THE YEAR AT RELC-NEAP MALVAR, BATANGAS** on **MARCH 1, 2025** to **DECEMBER 31, 2025**;

WHEREAS, the Approved Budget for the Contract (ABC) is **SIX HUNDRED FIFTY-EIGHT THOUSAND NINE HUNDRED NINETY-SIX PESOS AND 27/100 (Php658,996.27)**;

WHEREAS, Section 53.9 of the 2016 Revised Implementing Rules and Regulations (R-IRR) of Republic Act 9184, otherwise known as the “Government Procurement Reform Act of 2003”, allows an agency to resort to Small Value Procurement as alternative method of procurement where the amount involved does not exceed the threshold amount of One Million Pesos (Php1,000,000.00) as prescribed in Annex “H” thereof;

WHEREAS, the Request for Quotation (RFQ) was posted in the Philippine Government Electronic Procurement System (PhilGEPS), office website and conspicuous bulletin board in the premises of this Office on January 22, 2025 to January 28, 2025;

WHEREAS, RFQs were likewise sent to four (4) prospective suppliers as follows: (1) D’Great Stallion Security Agency, Inc.; (2) Corregidor Veteranos Security Agency, Inc.; (3) APEALL 6.0 Security Agency Inc.; and (4) Kings 2000 Security Services Corporation;

WHEREAS, two (2) suppliers submitted their respective proposals before the deadline for the submission of quotations, offering the following financial quotations, as read:
