**RECOMMENDATION TO APPROVE THE OFFER OF NATIONAL PRINTING OFFICE (NPO) FOR THE PRINTING AND DELIVERY OF QUARTER 1 AND 2 FOR GRADES 6, 9 & 10 SELF-LEARNING MODULES (SLMs) FOR FISCAL YEAR (FY) 2025**

**WHEREAS**, DepEd Region IV-A CALABARZON intends to procure for the printing and delivery of Quarter 1 and 2 for Grades 6, 9 and 10 Self-Learning Modules (SLMs) for FY 2025.

**WHEREAS**, this Office received an indicative allocation in the amount of **Three Hundred Sixteen Million Four Hundred Ninety-Eight Thousand Five Hundred Eighty-Seven Pesos (Php316,498,587.00)** for the production and delivery of Self-Learning Modules (SLMs) for FY 2025;

**WHEREAS**, on November 7, 2024, the BAC, BAC Secretariat, TWG and representative from the End-User conducted a pre-procurement conference to discuss the said allotment for the printing and delivery of SLMs for FY 2025;

**WHEREAS**, taking into consideration the market study showing a higher unit cost of the private printing company, the BAC and end-user proposed the procurement of Quarter 1 and 2 for Grades 6, 9 and 10 SLMs for FY 2025 through negotiated procurement under Agency-to-Agency considering the high volume of SLMs to be produced;

**WHEREAS**, on November 29, 2024 the BAC thru its Secretariat, initiated the procurement activity by sending quotation to APO Production Unit, Inc. (APO) and National Printing Office (NPO);

**WHEREAS**, in response APO and NPO submitted its proposal before the deadline for the submission of bids, offering the financial bids, as read:

with the total amount of **THREE HUNDRED SIXTEEN MILLION FOUR HUNDRED NINETY-SEVEN THOUSAND EIGHT HUNDRED SEVENTY-FIVE PESOS AND 20/100 (Php316,497,875.20)**.

**WHEREAS**, after evaluation of the quotation with the attached certificate, it was determined that the offer of **NATIONAL PRINTING OFFICE (NPO)** complied with the requirements and provides the most advantageous term to this Office;


