**BAC RESOLUTION**

**DECLARING FAILURE OF BIDDING CONDUCTED FOR THE PROCUREMENT OF EARLY PROCUREMENT OF SUPPLY AND DOOR TO DOOR DELIVERY OF TABLETS FOR ALTERNATIVE DELIVERY MODE (ADM) LEARNERS FOR DEPED REGION IV-A CALABARZON**

**WHEREAS**, on November 14, 2024, DepEd Regional Office IV-A CALABARZON has advertised its procurement activity for the **EARLY PROCUREMENT OF SUPPLY AND DOOR TO DOOR DELIVERY OF TABLETS FOR ALTERNATIVE DELIVERY MODE (ADM) LEARNERS FOR DEPED REGION IV-A CALABARZON (ROIVA-2024-11)** in the Philippine Government Electronic Procurement System (PhilGEPS) website, office website, and in conspicuous bulletin board of the Office;

**WHEREAS**, the indicative allocation amount is **TWENTY-ONE MILLION FIFTY-FOUR THOUSAND PESOS (PHP 21,054,000.00)**;

**WHEREAS**, on November 25, 2024, a pre-bid conference was held followed by a bid submission and opening on December 9, 2024. However, no bid was submitted for the said procurement;

**WHEREAS**, Section 35.1.a provides that the BAC shall declare a failure of bidding when no bids are received;

**NOW, THEREFORE**, the **BAC** hereby **RESOLVES** as it hereby **RESOLVED**:

1. **To DECLARE** failure of bidding;
2. **To RECOMMEND** the immediate procurement of the same through re-posting upon approval of the General Appropriations Act (GAA) of FY2025; and
3. **To RECOMMEND** to the Head of the Procuring Entity the approval of the foregoing findings.
