COMPOSITION AND NUMBER OF ATHLETES IN BALL GAMES

To: Schools Division Superintendents

- 1. In reference to DepEd Memorandum No. 174, s. 20161 and DepEd Memorandum No. 005, s. 20232, this Office, through the Education Support Services Division, directs the Schools Division Offices to comply with the required composition and number of athletes, particularly for the ball games (Basketball, Baseball, Football, Futsal, Sepaktakraw, Softball, and Volleyball) in the 2025 Regional Athletic Association Meet (RAAM). This is in compliance with the Palarong Pambansa standards and aims to ensure efficiency and effectiveness in the selection of athletes who shall participate in the next level of sports competitions.
2. In addition, the Schools Division Offices are encouraged to provide a maximum of three reserved athletes in each ball game to ensure smooth and efficient representation in the 2025 RAAM. Hereunder, is the prescribed number including the reserved athletes:
