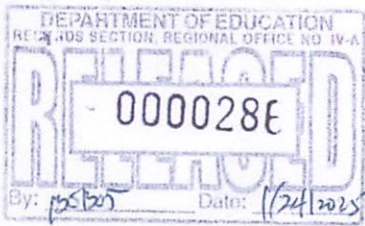

**CONDUCT OF SCREENING AND ACCREDITATION OF THE
PARTICIPANTS IN THE 2025 RAAM**

To: **Schools Division Superintendents**

1. In reference of the existing policy and guidelines, this office through the RSAC will conduct the screening and accreditation of the participants for the 2025 RAAM. The Head of Delegation for the Regional Meet must submit the documentation of athletes, coaches, assistant coaches, and chaperons for review and verification by the Regional Screening and Accreditation Committee (RSAC).
2. Relative to this, the medical and dental team members must be present on **February 17-19, 2025**, while all members of the Regional Screening and Accreditation Committee must attend the screening and accreditation on **February 17-21, 2025**. The list of members of the RSAC is attached herewith. The venue for this activity will be announced on a separate issuance.
3. The deadline for submission and digitization of the records of the athletes shall be on **February 16, 2025**.
4. Travel and other related expenses relative to the conduct of this activity will be charged against the regional funds, while the SDO, shall be charged against their local funds, subject to the usual accounting and auditing rules and regulations.
