MONITORING OF READINESS OF PARTICIPATING SCHOOLS IN THE INTERNATIONAL LARGE SCALE STUDENT ASSESSMENT (ILSSA)

- 1. Pursuant to the Unnumbered DepEd Memorandum s. 2025, dated February 5, 2925, re: Conduct of Weekly Readiness Monitoring, this office announces the conduct of onsite monitoring of the ILSSA participating schools from February 17-26, 2025, to March 3-7, 2025.
- 2. The objective of this activity is to ensure that all sample schools are adequately equipped and prepared for the test within the remaining time available for support and intervention.
- 3. The Regional Monitoring Team is composed of the Top Management, Education Program Supervisors, Senior Education Program Specialists and Information Communication Technology Personnel and other identified personnel of the region.
- 4. The Regional Monitors are expected to render reports and submit the same for consolidation of the Regional ILSSA Focal Person using the attached monitoring tool.
- 5. The Monitoring Officials and schools are expected to comply with **R.A. 6713**, the Code of Conduct and Ethical Standards for Public Officials and Employees, especially Section 7d. "Public Officials and employees shall not solicit or accept, directly or indirectly, any gift, gratuity, favor, entertainment, loan, or anything of monetary value from any person in the course of their official duties or in connection with any operation being regulated by, or any transaction which may be affected by the functions of their office." And Section 4 of Article VIII under Code of Ethics for Professional Teachers states that "A teacher shall not accept favours or gifts from learners, their parents or others in their behalf in exchange for requested concessions, especially if undeserved".
