**CONDUCT OF STAKEHOLDER CONSULTATIONS ON THE
PROPOSED SENIOR HIGH SCHOOL (SHS)
CURRICULUM REFORM**

To **Schools Division Superintendents**

1. In reference to the Office of the Undersecretary for Curriculum and Teaching Memorandum numbered DM-CT-2025-002 titled *Curriculum and Teaching (CT) Interface with Curriculum and Human Resource Officials and Field Personnel on the Proposed Senior High School (SHS) Curriculum*, this Office, through the Curriculum and Learning Management Division (CLMD), shall conduct **Stakeholder Consultations on the Proposed SHS Curriculum Reform** on January 30 to February 13, 2025 at venues within CALABARZON Schools Division Offices (SDOs).
2. The activity aims to:
 - 2.1. collect comprehensive feedback from key stakeholders on the proposed features of the SHS Curriculum Reform;

 - 3.1. parents, students (preferably Grade 10, 11, and 12), SHS teachers, school heads/administrators from both public and private schools
 - 3.2. industry partners
 - 3.3. Technical Vocational Institutions
 - 3.4. external partners supporting SHS
4. SDOs are encouraged to conduct face-to-face (F2F) consultations via focus group discussions (FGD).
