**BAC RESOLUTION**

**RECOMMENDING TO THE HEAD OF PROCURING ENTITY THE AWARD OF CONTRACT TO FOCAL MANAGING LOOP INC. FOR THE PROCUREMENT OF CATERING SERVICES FOR THE CONDUCT OF SCREENING AND ACCREDITATION OF THE PARTICIPANTS IN THE 2025 RAAM**

**WHEREAS**, DepEd Regional Office IV-A CALABARZON has undertaken procurement of **CATERING SERVICES** for the **CONDUCT OF SCREENING AND ACCREDITATION OF THE PARTICIPANTS IN THE 2025 RAAM** on **FEBRUARY 17-21, 2025**;

**WHEREAS**, the Approved Budget for the Contract (ABC) is **ONE HUNDRED NINETY-SEVEN THOUSAND TWO HUNDRED FIFTY PESOS (Php197,250.00)**;

**WHEREAS**, Section 53.9 of the 2016 Revised Implementing Rules and Regulations (R-IRR) of Republic Act 9184, otherwise known as the “Government Procurement Reform Act of 2003”, allows an agency to resort to Small Value Procurement as alternative method of procurement where the amount involved does not exceed the threshold amount of One Million Pesos (Php1,000,000.00) as prescribed in Annex “H” thereof;

**WHEREAS**, the Request for Quotation (RFQ) was posted in the Philippine Government Electronic Procurement System, office website and conspicuous bulletin board in the premises of this Office from February 6, 2025 to February 10, 2025 at 9:00 a.m.;

**WHEREAS**, RFQs were sent to at least three (3) prospective suppliers as follows: (1) Focal Managing Loop Inc.; (2) DepEd Region IV-A CALABRAZON Multipurpose Cooperative; and (3) God’s Treasure Enterprises;

**WHEREAS**, one (1) Supplier submitted its proposal; **FOCAL MANAGING LOOP INC.** in the amount of **ONE HUNDRED NINETY-SEVEN THOUSAND ONE HUNDRED EIGHTY-FOUR PESOS AND 25/100 (Php197,184.25)**. Thus, **FOCAL MANAGING LOOP INC.** is declared as the lone bidder;

**WHEREAS**, after review and deliberation on the proposal, **FOCAL MANAGING LOOP INC.** complied with the requirements and declared as the Single Calculated and Responsive Quotation (SCRQ);

**NOW, THEREFORE**, the **BAC** hereby **RESOLVES** as it hereby **RESOLVED** to **RECOMMEND** to the Regional Director, as the Head of the Procuring Entity, the award of the project to **ONE HUNDRED NINETY-SEVEN THOUSAND ONE HUNDRED EIGHTY-FOUR PESOS AND 25/100 (Php197,184.25)**.
