BAC RESOLUTION

RECOMMENDING TO THE HEAD OF PROCURING ENTITY THE AWARD OF CONTRACT TO D'LUXE WATER REFILLING STATION FOR THE PROCUREMENT OF PURIFIED WATER FOR THE REGIONAL OFFICE FROM MARCH 1, 2025 TO DECEMBER 31, 2025

WHEREAS, DepEd Regional Office IV-A CALABARZON has undertaken **PROCUREMENT OF PURIFIED WATER FOR THE REGIONAL OFFICE FROM MARCH 1, 2025 TO DECEMBER 31, 2025;**

WHEREAS, the Approved Budget for the Contract (ABC) is **FORTY-NINE THOUSAND PESOS (Php49,000.00);**

WHEREAS, Section 53.9 of the 2016 Revised Implementing Rules and Regulations (R-IRR) of Republic Act 9184, otherwise known as the "Government Procurement Reform Act of 2003", allows an agency to resort to Small Value Procurement as alternative method of procurement where the amount involved does not exceed the threshold amount of One Million Pesos (Php1,000,000.00) as prescribed in Annex "H" thereof;

WHEREAS, the Request for Quotation (RFQ) was posted in the office website and conspicuous bulletin board in the premises of this Office from February 4, 2025 to February 10, 2025 at 9:00 a.m.;

WHEREAS, RFQs were sent to at least three (3) prospective suppliers as follows: (1) D'Luxe Water Refilling Station; (2) Jamss Water Refilling Station; and (3) Jordan's Water Station;

WHEREAS, one (1) Supplier submitted its proposal; **D'LUXE WATER REFILLING STATION** in the amount of **FORTY-NINE THOUSAND PESOS (Php49,000.00)**. Thus, **D'LUXE WATER REFILLING STATION** is declared as the lone bidder;

WHEREAS, after review and deliberation on the proposal, **D'LUXE WATER REFILLING STATION** complied with the requirements and declared as the Single Calculated and Responsive Quotation (SCRQ);

NOW, THEREFORE, the **BAC** hereby **RESOLVES** as it hereby **RESOLVED** to **RECOMMEND** to the Regional Director, as the Head of the Procuring Entity, the award of the project to **D'LUXE WATER REFILLING STATION** in the amount **FORTY-NINE THOUSAND PESOS (Php49,000.00)**.
