**BAC RESOLUTION**

**RECOMMENDING TO THE HEAD OF PROCURING ENTITY THE AWARD OF CONTRACT TO FOCAL MANAGING LOOP INC. FOR THE PROCUREMENT OF CATERING SERVICES FOR THE CONDUCT OF THE 2025 REGIONAL ATHLETIC ASSOCIATION MEET**

**WHEREAS**, DepEd Regional Office IV-A CALABARZON has undertaken procurement of **CATERING SERVICES** for the **CONDUCT OF THE 2025 REGIONAL ATHLETIC ASSOCIATION MEET** on **MARCH 1-8, 2025**;

**WHEREAS**, the Approved Budget for the Contract (ABC) is **EIGHT HUNDRED TEN THOUSAND PESOS (Php810,000.00)**;

**WHEREAS**, Section 53.9 of the 2016 Revised Implementing Rules and Regulations (R-IRR) of Republic Act 9184, otherwise known as the "Government Procurement Reform Act of 2003", allows an agency to resort to Small Value Procurement as alternative method of procurement where the amount involved does not exceed the threshold amount of One Million Pesos (Php1,000,000.00) as prescribed in Annex "H" thereof;

**WHEREAS**, the Request for Quotation (RFQ) was posted in the Philippine Government Electronic Procurement System, office website and conspicuous bulletin board in the premises of this Office from February 10, 2025 to February 14, 2025 at 9:00 a.m.;

**WHEREAS**, RFQs were sent to at least three (3) prospective suppliers as follows: (1) Jivic Catering Services; (2) Focal Managing Loop Inc.; and (3) DepEd Region IV-A CALABRAZON Multipurpose Cooperative;

**WHEREAS**, two (2) suppliers submitted their respective proposals before the deadline for the submission of quotations, offering the following financial quotations, as read:


