## BAC RESOLUTION

RECOMMENDING TO THE HEAD OF THE PROCURING ENTITY THE AWARD OF CONTRACT TO SUNRISE RIDGE CORPORATION (SOLESTE SUITES) FOR THE PROCUREMENT OF FOOD AND ACCOMMODATION FOR THE VETTING AND FINALIZATION OF TRAINING RESOURCE PACKAGE FOR ENHANCED SCHOOL HEADS DEVELOPMENT PROGRAM 3.0

WHEREAS, DepEd Regional Office IV-A CALABARZON has undertaken procurement of FOOD AND ACCOMMODATION for the VETTING AND FINALIZATION OF TRAINING RESOURCE PACKAGE FOR ENHANCED SCHOOL HEADS DEVELOPMENT PROGRAM 3.0 on MARCH 17-21, 2025;

WHEREAS, the Approved Budget for the Contract (ABC) is **ONE HUNDRED FIFTY-SIX THOUSAND PESOS (Php156,000.00)**;

**WHEREAS,** Section 53.9 of the 2016 Revised Implementing Rules and Regulations (R-IRR) of Republic Act 9184, otherwise known as the "Government Procurement Reform Act of 2003", allows an agency to resort to Small Value Procurement as alternative method of procurement where the amount involved does not exceed the threshold amount of One Million Pesos (Php1,000,000.00) as prescribed in Annex "H" thereof;
