**RECOMMENDING TO THE HEAD OF THE PROCURING ENTITY THE AWARD OF CONTRACT TO PINK PARSLEY CATERING SERVICES FOR THE PROCUREMENT OF CATERING SERVICES FOR THE ADMINISTRATIVE SERVICES DIVISION QUARTERLY DIVISION PROCESS REVIEW**

**WHEREAS**, DepEd Regional Office IV-A CALABARZON has undertaken procurement of **CATERING SERVICES** for the **ADMINISTRATIVE SERVICES DIVISION QUARTERLY DIVISION PROCESS REVIEW** on **MARCH 13-14, 2025, JUNE 24-25, 2025, SEPTEMBER 10-11, 2025 AND NOVEMBER 18-19, 2025;**

**WHEREAS**, the Approved Budget for the Contract (ABC) is **ONE HUNDRED FIFTEEN THOUSAND TWO HUNDRED PESOS (Php115,200.00);**

**WHEREAS**, Section 53.9 of the 2016 Revised Implementing Rules and Regulations (R-IRR) of Republic Act 9184, otherwise known as the “Government Procurement Reform Act of 2003”, allows an agency to resort to Small Value Procurement as alternative method of procurement where the amount involved does not exceed the threshold amount of One Million Pesos (Php1,000,000.00) as prescribed in Annex “H” thereof;

**WHEREAS**, the Request for Quotation (RFQ) was posted in the Philippine Government Electronic Procurement System (PhilGEPS), office website and conspicuous bulletin board in the premises of this Office from February 17, 2025 to February 21, 2025 at 9:00 a.m.;

**WHEREAS**, RFQs were sent to at least three (3) prospective suppliers as follows: (1) Focal Managing Loop Inc.; (2) God’s Treasure Enterprises; and (3) DepEd Region IV-A CALABARZON Multi-purpose Cooperative;

**WHEREAS**, one (1) Supplier submitted its proposal; **PINK PARSLEY CATERING SERVICES** in the amount of **ONE HUNDRED SEVEN THOUSAND FIVE HUNDRED TWENTY PESOS (Php107,520.00)**. Thus, **PINK PARSLEY CATERING SERVICES** is declared as the lone bidder;

**WHEREAS**, after review and deliberation on the proposal, **PINK PARSLEY CATERING SERVICES** complied with the requirements and declared as the Single Calculated and Responsive Quotation (SCRQ);

**NOW, THEREFORE**, the **BAC** hereby **RESOLVES** as it hereby **RESOLVED** to **RECOMMEND** to the Regional Director, as the Head of the Procuring Entity, the award of the project to **PINK PARSLEY CATERING SERVICES** in the amount of **ONE HUNDRED SEVEN THOUSAND FIVE HUNDRED TWENTY PESOS (Php107,520.00)**.


