RECOMMENDING TO THE HEAD OF THE PROCURING ENTITY THE AWARD OF CONTRACT TO FOCAL MANAGING LOOP INC. FOR THE PROCUREMENT OF CATERING SERVICES FOR THE CAPABILITY BUILDING ON THE DECONCENTRATION OF PAYROLL PREPARATION TO THE SCHOOLS DIVISION OFFICES (SDOs)

WHEREAS, DepEd Regional Office IV-A CALABARZON has undertaken procurement of CATERING SERVICES for the CAPABILITY BUILDING ON THE DECONCENTRATION OF PAYROLL PREPARATION TO THE SCHOOLS DIVISION OFFICES (SDOs) on MARCH 18-21, 2025;

WHEREAS, the Approved Budget for the Contract (ABC) is NINETY-FIVE THOUSAND FOUR HUNDRED PESOS (Php95,400.00);

WHEREAS, Section 53.9 of the 2016 Revised Implementing Rules and Regulations (R-IRR) of Republic Act 9184, otherwise known as the "Government Procurement Reform Act of 2003", allows an agency to resort to Small Value Procurement as alternative method of procurement where the amount involved does not exceed the threshold amount of One Million Pesos (Php1,000,000.00) as prescribed in Annex "H" thereof;

WHEREAS, the Request for Quotation (RFQ) was posted in the Philippine Government Electronic Procurement System, office website and conspicuous bulletin board in the premises of this Office from February 19, 2025 to February 24, 2025 at 9:00 a.m.;

WHEREAS, RFQs were likewise sent to at least three (3) prospective suppliers as follows: (1) Focal Managing Loop Inc.; (2) God's Treasure Enterprises; and (3) DepEd Region IV-A CALABRAZON Multipurpose Cooperative;

WHEREAS, one (1) Supplier submitted its proposal; FOCAL MANAGING LOOP INC. in the amount of NINETY-TWO THOUSAND NINE HUNDRED THIRTY-FIVE PESOS AND 50/100 (Php92,935.50). Thus, FOCAL MANAGING LOOP INC. is declared as the lone bidder;

WHEREAS, after review and deliberation on the proposal, **FOCAL MANAGING LOOP INC.** complied with the requirements and declared as the Single Calculated and Responsive Quotation (SCRQ);

NOW, THEREFORE, the **BAC** hereby **RESOLVES** as it hereby **RESOLVED** to **RECOMMEND** to the Regional Director, as the Head of the Procuring Entity, the award of the project to **FOCAL MANAGING LOOP INC.** in the amount of **NINETY-TWO THOUSAND NINE HUNDRED THIRTY-FIVE PESOS AND 50/100 (Php92,935.50).**
