**WHEREAS**, DepEd Regional Office IV-A CALABARZON has undertaken procurement of **FOOD AND ACCOMMODATION** for the **WORKSHOP ON THE DEVELOPMENT OF M&E FRAMEWORK AND TOOLS IN THE IMPLEMENTATION OF PROGRAMS, PROJECTS, AND ACTIVITIES (PPAs)** on **MARCH 27-28, 2025**;

**WHEREAS**, the Approved Budget for the Contract (ABC) is **ONE HUNDRED TWENTY-EIGHT THOUSAND PESOS (Php128,000.00)**;

**WHEREAS**, Section 53.9 of the 2016 Revised Implementing Rules and Regulations (R-IRR) of Republic Act 9184, otherwise known as the “Government Procurement Reform Act of 2003”, allows an agency to resort to Small Value Procurement as alternative method of procurement where the amount involved does not exceed the threshold amount of One Million Pesos (Php1,000,000.00) as prescribed in Annex “H” thereof;

**WHEREAS**, the Request for Quotation (RFQ) was posted in the Philippine Government Electronic Procurement System (PhilGEPS), office website and conspicuous bulletin board in the premises of this Office on February 19, 2025 to February 24, 2025;

**WHEREAS**, RFQs were likewise sent to at least three (3) prospective suppliers as follows: (1) Tagaytay Viewpark Hotel; (2) Sunny Glades Properties Corp. (Tagaytay Haven Hotel); and (3) Tagaytay Automart Inc. (Tagaytay Country Hotel);

**WHEREAS**, two (2) suppliers submitted their respective proposals before the deadline for the submission of quotations, offering the following financial quotations, as read:
