## BAC RESOLUTION

**RECOMMENDING TO THE HEAD OF THE PROCURING ENTITY THE AWARD OF CONTRACT TO SUNRISE RIDGE CORPORATION (SOLESTE SUITES) FOR THE PROCUREMENT OF FOOD AND ACCOMMODATION FOR THE DESIGNING AND DEVELOPMENT OF LEARNING RESOURCE PACKAGE FOR COMPETENCY ENHANCEMENT TRAINING FOR REGIONAL EMPLOYEES CEnTRE (LEVELS 1 AND 2)**

**WHEREAS**, DepEd Regional Office IV-A CALABARZON has undertaken procurement of **FOOD AND ACCOMMODATION** for the **DESIGNING AND DEVELOPMENT OF LEARNING RESOURCE PACKAGE FOR COMPETENCY ENHANCEMENT TRAINING FOR REGIONAL EMPLOYEES CEnTRE (LEVELS 1 AND 2)** on **MARCH 12-14, 2025**;

**WHEREAS**, the Approved Budget for the Contract (ABC) is **ONE HUNDRED TWENTY THOUSAND PESOS (Php120,000.00)**;

**WHEREAS**, Section 53.9 of the 2016 Revised Implementing Rules and Regulations (R-IRR) of Republic Act 9184, otherwise known as the "Government Procurement Reform Act of 2003", allows an agency to resort to Small Value Procurement as alternative method of procurement where the amount involved does not exceed the threshold amount of One Million Pesos (Php1,000,000.00) as prescribed in Annex "H" thereof;

**WHEREAS**, the Request for Quotation (RFQ) was posted in the Philippine Government Electronic Procurement System, office website and conspicuous bulletin board in the premises of this Office from February 24, 2025 to February 28, 2025 at 9:00 a.m.;

**WHEREAS**, RFQs were likewise sent to at least three (3) prospective suppliers as follows: (1) Sunrise Ridge Corporation (Soleste Suites); (2) Red Hotel; and (3) Madison 101 Hotel;

**WHEREAS**, two (2) suppliers submitted their respective proposals before the deadline for the submission of quotations, offering the following financial quotations, as read:


