BAC RESOLUTION

RECOMMENDING TO THE HEAD OF THE PROCURING ENTITY THE AWARD OF CONTRACT TO GOD'S TREASURE ENTERPRISES FOR THE PROCUREMENT OF CATERING SERVICES FOR THE PROGRAM ON WELFARE FOR THE EMPLOYEES OF REGIONAL OFFICE (POWER-O): PARTICIPATION OF REGIONAL OFFICE PERSONNEL TO PHYSICAL WELLNESS ACTIVITIES

WHEREAS, DepEd Regional Office IV-A CALABARZON has undertaken procurement of **CATERING SERVICES** for the **PROGRAM ON WELFARE FOR THE EMPLOYEES OF REGIONAL OFFICE (POWER-O): PARTICIPATION OF REGIONAL OFFICE PERSONNEL TO PHYSICAL WELLNESS ACTIVITIES** on **MARCH 17, 2025, April 7-30, 2025** and **AUGUST 1, 2025**;

WHEREAS, the Approved Budget for the Contract (ABC) is **ONE HUNDRED EIGHT THOUSAND SEVEN HUNDRED FIFTY PESOS (Php108,750.00)**;

WHEREAS, Section 53.9 of the 2016 Revised Implementing Rules and Regulations (R-IRR) of Republic Act 9184, otherwise known as the "Government Procurement Reform Act of 2003", allows an agency to resort to Small Value Procurement as alternative method of procurement where the amount involved does not exceed the threshold amount of One Million Pesos (Php1,000,000.00) as prescribed in Annex "H" thereof;

WHEREAS, the Request for Quotation (RFQ) was posted in the Philippine Government Electronic Procurement System, office website and conspicuous bulletin board in the premises of this Office from February 25, 2025 to March 3, 2025 at 9:00 a.m.;

WHEREAS, RFQs were likewise sent to four (4) prospective suppliers as follows: (1) Focal Managing Loop Inc.; (2) Pink Parsley Catering Services; (3) DepEd Region IV-A CALABRAZON Multipurpose Cooperative; and (4) God's Treasure Enterprises;

WHEREAS, one (1) Supplier submitted its proposal; **GOD'S TREASURE ENTERPRISES** in the amount of **ONE HUNDRED ONE THOUSAND TWO HUNDRED FIFTY PESOS (Php101,250.00)**. Thus, **GOD'S TREASURE ENTERPRISES** is declared as the lone bidder;

WHEREAS, after review and deliberation on the proposal, **GOD'S TREASURE ENTERPRISES** complied with the requirements and declared as the Single Calculated and Responsive Quotation (SCRQ);

NOW, THEREFORE, the **BAC** hereby **RESOLVES** as it hereby **RESOLVED** to **RECOMMEND** to the Regional Director, as the Head of the Procuring Entity, the award of the project to **GOD'S TREASURE ENTERPRISES** in the amount of **ONE HUNDRED ONE THOUSAND TWO HUNDRED FIFTY PESOS (Php101,250.00)**.


