WHEREAS, DepEd Regional Office IV-A CALABARZON has undertaken procurement of CATERING SERVICES for the WORKSHOP ON ASSESSING STRATEGIC TECHNICAL ASSISTANCE PLAN (BLENDED) on MARCH 28, 2025;
