BAC RESOLUTION

RECOMMENDING TO THE HEAD OF THE PROCURING ENTITY THE AWARD OF CONTRACT TO SUNRISE RIDGE CORPORATION (SOLESTE SUITES) FOR THE PROCUREMENT OF FOOD AND ACCOMMODATION FOR THE CAPACITY BUILDING ON GENDER MAINSTREAMING ON THE ORGANIZATION FOCUSING ON CULTURAL SENSITIVITY AND INCLUSIVE LEADERSHIP

WHEREAS, DepEd Regional Office IV-A CALABARZON has undertaken procurement of **FOOD AND ACCOMMODATION** for the **CAPACITY BUILDING ON GENDER MAINSTREAMING ON THE ORGANIZATION FOCUSING ON CULTURAL SENSITIVITY AND INCLUSIVE LEADERSHIP** on **MARCH 26-28, 2025**;

WHEREAS, the Approved Budget for the Contract (ABC) is **TWO HUNDRED FORTY THOUSAND PESOS (Php240,000.00)**;

WHEREAS, Section 53.9 of the 2016 Revised Implementing Rules and Regulations (R-IRR) of Republic Act 9184, otherwise known as the “Government Procurement Reform Act of 2003”, allows an agency to resort to Small Value Procurement as alternative method of procurement where the amount involved does not exceed the threshold amount of One Million Pesos (Php1,000,000.00) as prescribed in Annex “H” thereof;

WHEREAS, the Request for Quotation (RFQ) was posted in the Philippine Government Electronic Procurement System on March 4, 2025, in the office website and conspicuous bulletin board in the premises of this Office from March 3, 2025 to March 7, 2025 at 9:00 a.m.;

WHEREAS, RFQs were likewise sent to at least three (3) prospective suppliers as follows: (1) Red Hotel Inc.; (2) Sunrise Ridge Corporation (Soleste Suites); and (3) L&B International Tourist Hotel Inc. (Camelot Hotel);

WHEREAS, five (5) suppliers submitted their respective proposals before the deadline for the submission of quotations, offering the following financial quotations, as read:

WHEREAS, on March 11, 2025, the end-user submitted an ocular inspection conducted at **ORACLE HOTEL AND RESIDENCES CORP.** being the Lowest Calculated Bid (LCB) based on the submitted quotations;

WHEREAS, in the evaluation report during the ocular inspection, **ORACLE HOTEL AND RESIDENCES CORP.** failed to comply with the specifications set by this office, as follows:

- a. *Internet connection in the function halls and rooms is poor or weak. It ranges from 1.2 to 2.7 mbps only, which is below the set internet speed of at least 40 mbps;*
- b. *The function rooms/halls are not well-lit and the two pillars obstruct the audience's view of the presentation;*
- c. *There are cracks or broken tiles along the corridor going to the rooms, posing a potential hazard to the participants;*
- d. *Most rooms lack windows or access to natural light;*
- e. *Mobility inside the rooms is limited due to space constraints;*

WHEREAS, on March 12, 2025, the end-user submitted an ocular inspection conducted at **SUNRISE RIDGE CORPORATION (SOLESTE SUITES)** being the Second Lowest Calculated Bid (LCB) stating the following:

- a. *The venue is accessible by public transportation;*
- b. *The internet connection in the training hall can still be augmented during the conduct of the activity despite its 78 mbps during the speed test;*
- c. *Based on the previous feedback of the participants on the variety of food served and its delicious taste keep them coming back for more;*
- d. *The venue is fully compliant with the training venue specification or requirements;*

WHEREAS, the report containing the result of the evaluation and its attachments is attached hereto as Annex "A" and Annex "B" and made an integral part hereof;


WHEREAS, after review and deliberation on the proposals, **SUNRISE RIDGE CORPORATION (SOLESTE SUITES)** complied with the requirements and is hereby declared as the Lowest Calculated and Responsive Quotation (LCRQ);

NOW, THEREFORE, the **BAC** hereby **RESOLVES** as it hereby **RESOLVED** to **RECOMMEND** to the Regional Director, as the Head of the Procuring Entity, the award of the project to **SUNRISE RIDGE CORPORATION (SOLESTE SUITES)** in the amount of **TWO HUNDRED TWENTY-TWO THOUSAND PESOS (Php222,000.00)**.
