SUBJECT : **INVITATION TO BID FOR THE HOSTING OF THE 2027 PALARONG PAMBANSA**

DATE : **27 August 2024**

The Department of Education (DepEd), in coordination with the Philippine Sports Commission (PSC) and the Department of Interior and Local Government (DILG), shall conduct the **67<sup>th</sup> edition** of the **Palarong Pambansa** to be staged in **Luzon** in **2027**.

In this regard, all concerned are enjoined to facilitate the dissemination of this invitation and identify prospective local government units (LGUs) under your region's jurisdiction that will participate in the **bidding to host the 2027 Palarong Pambansa**.

Determination of prospective bidder-LGUs shall be based on its capability and readiness to host the annual scholastic multi-sports competition, specifically on the following criteria based on Section 14, Rule III of the Implementing Rules and Regulations (IRR) of Republic Act (RA) 10588 otherwise known as the *Palarong Pambansa Act of 2013*:

- The playing venues to be used must be accessible and free to the general public, well-secured, ready to be used, and more importantly, are of international standard;
- The billeting schools for the athletic delegations and technical officials must have sufficient and adequate sleeping quarters, comfort rooms, shower areas, wash areas, and kitchen/dining areas;
- The playing venues and billeting schools must be capable of providing basic services such medical and dental, communication and internet, adequate water supply, and uninterrupted electric power supply;

- d. The peace and order situation in the locality must be excellent and conducive to staging a national activity;
- e. The LGU must be willing and capable to shoulder expenses necessary for the hosting of the *Palarong Pambansa* that include, but not limited to, construction and renovation of sports facilities, billeting schools, and other infrastructure requirements; and
- f. Manifestation of uncompromising unity and support of all socio-economic political groups, government and non-government entities, and private sector in the locality to ensure the successful conduct of the *Palarong Pambansa*.

An official communication – addressed to the DepEd Secretary through the *Palarong Pambansa* Secretary General, duly signed by the chief executive of the LGU – signifying the LGUs intent to bid for the hosting of the 2027 *Palarong Pambansa* must be transmitted to the *Palarong Pambansa* Secretariat at email address [palarong.pambansa@deped.gov.ph](mailto:palarong.pambansa@deped.gov.ph) on or before **September 15, 2024**.

Enclosed herewith are the **Required Specifications for Playing Venues and Billeting Schools** for reference and guidance of all concerned and the prospective bidder-LGUs.
