CREATION OF TECHNICAL WORKING GROUP (TWG) AND SUBMISSION OF REPORTS RELATED TO THE GULAYAN SA PAARALAN PROGRAM (GPP) AND INTEGRATED SCHOOL NUTRITION MODEL (ISNM)

To Schools Division Superintendents

- 1. Relative to OM-OUOPS-2024-08-00378¹, this Office, through the Education Support Services Division (ESSD), hereby requests the creation of a Technical Working Group (TWG) and the submission of the updated list of schools implementing the Gulayan sa Paaralan Program (GPP) and lighthouse schools for the Integrated School Nutrition Model (ISNM), along with the corresponding accomplishment reports.
- 2. It is worth noting that Item 1 of the aforementioned guidelines states that the Division TWG, composed of personnel from the School Governance and Operations Division (SGOD) and the Curriculum Implementation Division (CID), must designate a focal person and a co-focal person. To ensure balanced representation, if the focal person is from SGOD, the co-focal must be from CID, and vice versa. A sample reference for the composition is provided in **Annex A**.
